



Meeting Minutes - Midway USA Chapter of NCRS, Inc.

The August 2020 monthly meeting was virtually held on the 8th, and called to order at 9:07 A.M. by our chapter Vice Chairman, Dave Houlihan, due to the absence of our Chairman, Rick Smiley. There were approximately 15 in attendance.

Old Business:

- Dave Houlihan took over for Rick who was absent as he had work to do for "The Church". Dave inquired at 9:07 when the meeting was to start! Seems like that would be the first thing Rick would have told Dave, but as it turned out, Rick didn't give much material for Dave to discuss with his peons.
- It was pointed out that the newsletter said the meeting was to be at 9:00 AM. No one pointed out that the Membership Chairman, Dale Green, in his email sent out last Sunday about today's meeting, stated it would start at 9:30 after everybody checked in at "9:00 (ish)" so that all the bugs could be worked out.
- Dale also pointed out that John Jones would be the host since Dale would be absent, but he didn't say anything about having to be at Church! John was an excellent host, and didn't hardly say anything derogatory.
- After all that, we had a respectable meeting with a respectable amount of viewers/participators. The difference this time was, due to the Covid, Vinnie offered to publish cancellations of events also!
